Eligibility

- **Organization** located in the East Bay commissioning a Bay Area artist **OR**
- Artist living in the East Bay, a fiscal sponsor is required (does not have to be in the Bay Area)
- Must not have been an EBFA awardee during the 2023 calendar year
- Commission must support a new work

Organization or Artist Application

- Should I apply as an individual artist or as an organization?
- A few questions to help you answer this question:
 - Who is truly leading the work?
 - Who is commissioning the project?
 - Whose audience or base is being expanded?

What the panel will be looking for:

- Creation of new work and support of individual artists:
 - Clear vision with strong artistic practice.
 - 100% of EBFA Funds and request must be allocated to the **lead artist(s)** (\$5,000 up to \$25,000).
 - EBFA funds will support up to 75% of the total project cost.
- Engagement with community/audience.
- Social justice themes in work.

How the Panel Will Score Applications

- Clear articulation of the project and how it aligns with the artist's artistic practice/creative development.
- Demonstrated ability to complete project.
- Plan to reach/engage your audience.
- Strength of social justice themes & issues.
- Organizations:
 - Rationale for selecting the artist(s)
 - Ability to manage the project



Work Sample

- 1 or 2 work samples per lead artist
- Audio or Video:
 - .mp4 or .mov
 - No more than 3 minutes long
 - Upload to Youtube or Vimeo
- Photos
- Upload work sample via Survey Monkey Apply

East Bay Fund for Artists Timeline



- Deadline to apply: September 9, 2024
- Panel Decision: Early November
- Grants Disbursed: Mid November
- East Bay Premiere: within 1 year of receipt of award



Fiscal Sponsorship

- A fiscal sponsor is required for all artists and organizations who do not have their own 501c3.
 - Does not need to be located in the East Bay.

- Many local nonprofits provide sponsorship to a smaller number of projects. If you've worked closely with a nonprofit organization in the past, ask if they have sponsorship opportunities.
